#### PARK CAR

the users of the annual berth have the right to use the parking lot in Marina Betina for their personal vehicle along with the duration of the Berth Contract \* Marina Betina is not responsible for damage to the vehicle and objects in the vehicle during use parking

#### VALID DATE

the Annual Berth Contract is concluded for a determined period of time, specifically from 1st April of the c.y. to 31st March of the n.y. and it is not valid after the contracted time



#### CAT

berth's category is determined on the basis of the length over all (including all the additionals from bow to stern) and maximium beam of the vessel \* marina Betina reserves the right to remeasure the vessels in the port

#### LOA x Bmax

the vessels in the port whose lenght overall or maximum width is a whole number (e.g. 7,00 x 3,00) are charged according to the rate for subsequent higer berth category

#### YACHT BOX

crew members of the vessel in the port have the right to use connections to water and electricity (16 Ah), sanitary facilities and showers with hot water only for their personal needs

- the use of water and electricity connections is allowed only and exclusively with the presence of the crew members on the vessel in the port or with the open Work order at the reception of Marina Betina
- crew members on the vessel in the port are obliged to only use water hoses with a functioning connection to the tap and with a closing valve
- the daily use of connections for electricity of 32 Ah is charged in the amount of +10% from the daily price of a berth
- the use of water for washing the vessel in the port will be charged by the valid Price list of the marina Betina

# MULTI HULL

use of a berth or a shore standfor multihulls with maximium width up to 6.5 m is charged with +60% more of its price, for multihulls with maximum width over 6.5 m is charged with +100% more of its price

# CHECK IN

the person who steers the vessel is obliged, immediately upon arrival of the vessel in the port, to report the arrival at the reception desk of the marina Betina and to deliver the certificate of seaworthiness as well as the list of crew members of the vessel in the port

#### CHECK OUT

the person who steers the vessel is obliged, at least one hour before the departure of the vessel from the port, to report the departure at the reception desk of the marina Betina

in period from 01.10. c.y. to 31.03. n.y. we approve discount of −20% on TRANSIT LOG prices

This service is designed to provide owners with a close and supervised presence on their vessels during the winter months, ensuring proper maintenance and protecting the vessel from adverse weather conditions. Additionally, depending on the package chosen, photos or videos can be sent to boat owners documenting the boat conditions, the activities carried out and any changes. This provides additional transparency and allows owners to be informed about the condition of their vessels even when they are not physically present.

The Live-in service gives boat owners peace of mind knowing that their boats are being monitored and regularly maintained during the winter period, reducing the risk of unwanted problems or damage. In addition, it allows owners to stay close to their vessels and enjoy them even during the winter months.

**Control of mooring lines and fenders:** Properly installed and maintained mooring lines and fenders are key to the safety of your vessel during winter mooring.

#### **COMFORT PACKAGE**

All from **BASIC package plus:** 

**Salt rinsing of the vessel:** Thorough rinsing of the vessel to remove salt residues and prevent corrosion or damage caused by salt water (if necessary in the winter months from 01.10 - 31.03.)

**Starting the engine once a month:** This service ensures that your engine remains in optimal condition and ready for use, thus reducing the risk of problems caused by long periods of inactivity.

**PREMIUM PACKAGE** 

All from COMFORT package plus:

**Electricity connection:** (if none of the guests or crew are on board): This service ensures that your batteries are in an optimal state of charge, ready for use whenever needed, thus preventing potential problems caused by empty or low-charge batteries.

**Customized reports:** Reporting to vessel owners with more detailed information about the activities carried out.

- Marina Betina is not held responsible for any damage on the vessel and equipment of the vessel in the period when the owner is using the services of third parties for supervision, maintenance or performance of works on the vessel in the port
- Third parties performing the works on the vessel in the port must have a registered activity

Vessel owner is obliged to immediately clean the work performance area after the completion of works on the vessel in the port. Otherwise, Marina Betina will charge cleaning costs at the price of the daily berth rental.
